

## **ELECTION NOTICE AND INVITATION TO PROPOSE CANDIDATES**

### **MEMBERS OF THE DEPARTMENT COUNCIL – THE DEPARTMENT OF CLINICAL SCIENCE - GROUP A, B & C**

There will be elected members (and alternates) to the Department Council at the Department of Clinical Science in group A, B & C.

**The deadline for proposals of members (group A, B & C) is set to Friday 4 April 2025**

Group A, B & C are represented on the Department Council as follows:

Group C	Technical and administrative employees	1	4 years – from 01.08.2025 to 31.07.2029
Group D	Students (will be elected in the election assembly)	2	1 year – from 01.08.2025 to 31.07.2026

In addition to permanent members, at least 2 alternates must be elected in each group.

Eligible voters in the groups A, B & C have the right to propose candidates for election in the groups to which they belong.

Written nominations must be signed and submitted by at least the same number of proposers as the number of candidates the proposal contains (ie 1 to 1). No one can suggest more than one proposal. A proposer cannot propose himself/herself as a candidate.

The proposed candidate must be eligible. Proposal with more than one candidate should take account of gender balance. The candidates must understand Norwegian.

In order to be eligible and vote you must have at least a 50 % position at the Department of Clinical Science, Faculty of Medicine, and a position in the same category to be elected.

An employee who is eligible is obliged to accept election and to act in the post as elected. Anyone who has had a post, may refuse re-election for an equally long period in which he/she has served continuously. If a candidate is proposed who can claim exemption from election, the proposal shall be enclosed with his/her written consent.

The Election Board may, upon application, exempt a proposed candidate from standing for election

if there are weighty work and welfare purposes.

## **Date of election**

The election will take place **from Monday 2 June ( 09:00AM ) to Thursday 5 June 2025 (12:00AM )**

The election will be conducted electronically and as a preference-election.
